### 1 Objective/目标

This document describes the methods and rules for the quotation of sustainable textile certification, with the aim of ensuring the uniformity and fairness of the quotation mechanism./本文件描述了可持续发展纺织品认证的报价的方法和规则，目的是保证报价机制的统一，公平。

### 2 Quote mechanism/报价机制

Fees for sustainable textiles certification are divided into the following parts:/可持续发展纺织品认证收费项目分为以下部分：

- application fee/申请费
- audit fee/审核费
- Evaluation fee/评估费
- license fee /许可费
- travel fee/差旅费
- Sampling test fee/取样检测费
- Transaction certificate fee 贸易证费用

#### 2.1 Application fee/申请费

The application fee includes the fee of initial or re-certification application acceptance, application review and contract review, RMB 1000 per time./申请费用包括初次或再次认证申请受理、申请评审、合同评审的费用，1000 元人民币/每次。

#### 2.2 Audit fee/审核费

##### 2.2.1 Main site fee/主场所费用

The audit fee includes the cost of inspecting the client's relevant sites and writing the report,the fee standard is as follows:/审核费用包含了检查员检查客户的相关场所、报告撰写的费用，其收费标准如下：

### 2.3 Evaluation fee/评估费

The evaluation fee includes report evaluation, drafting certification conclusion, issuing scope certificate and technical support, etc. The cost is calculated based on the number of sites and the activities to be certified for each site. The assessment fee for traders and machining sites that do not have any processing or manufacturing activities themselves and do not outsource any processing or manufacturing activities is RMB 2,000, and the assessment fee for enterprises involved in wet processing is RMB 3,000 / site. If an enterprise intends to certify the activity of both mechanical processing and wet processing, the assessment fee is only charged according to the type of wet processing. /评估费包含了报告评估、起草认证结论、颁发范围证书以及技术支持等，费用以场所数和每个场所拟认证的活动计。本身没有任何加工或制造活动，也没有外包任何加工或制造活动的贸易商和机械加工场所的评估费是 2000 元人民币，涉及湿加工的企业评估费是 3000 元人民币/每场所。如一个企业拟认证的活动同时有机械加工和湿加工，评估费按湿加工类型收取。

### 2.4 Travel fee/差旅费用

The travel expense depends on the location of the place and is generally based on the actual travel expense. /差旅费视场所的位置而定，一般以实际发生的差旅费用为准。

### 2.5 License fee/许可费

Each main site in accordance with the standards of the application for certification are charged an annual fee, the fee standard is as follows: /每个主场所按照所申请认证的标准分别是收取年费，其收费标准如下：

For the standards of Textile Exchange, each subsequent site will charge license fees according to the following standards, and the subcontractors will not charge annual fees. /对于 Textile Exchange 的标准，每个分场所按照以下标准收取年费，分包单位不收取年费。

For subcontractors in GOTS standard, the annual fee for each subcontractor is also 1500 RMB/site.  
对于 GOTS 标准里的分包单位，每个分包单位的年费收取标准也是 1500 元/场所。

### 2.6 Sampling test fee/取样检测费

The above daily quotation does not include the cost of product testing. The cost of product testing shall be subject to the actual occurrence./以上人日报价均不含产品检测费用，产品检测费用以实际发生为准。

### 2.7 Transaction certificate fee/贸易证费用

TC fee :The first 10 TCs are free. For subsequent TCs, the basic charge is RMB 260 per TC. For each additional shipment, an extra RMB 50 will be added/贸易证费用：前 10 票 TC 免费，之后每票 TC 基础收费为 260 元人民币，每增加一个运单，增加 50 元人民币

## 3 Joint audit fee

Multi-standard joint certification, the higher the cost shall prevail, each additional standard, according to the following provisions to increase the certification fee: /多标准联合认证，以费用较高者为准，每增加一个标准，按照以下规定增加认证费用：

## 4 Annual Certification Fee/年度认证费用

4.1 For the first certification, KCB shall make the annual certification quotation according to the information in the application form filled in by the enterprise and the quotation rules above./首次认证，KCB 根据企业填写的申请表里的信息，参照以上报价规则制定年度认证报价。

4.2 Once again, if the enterprise did not update the application form, it will automatically make a quotation according to the certification information of the previous year./再次认证时，如果企业没有更新申请表，就自动按照上一年的认证信息制作报价。

4.3 KCB may decide to perform remote inspections instead of on-site inspections for traders who do not have any processing or manufacturing activities of their own and who do not outsource any processing or manufacturing activities. However, Remote audit of the annual certification costs in the accounting, need to remove travel expenses./对于本身没有任何加工或制造活动，也没有外包任何加工或制造活动的贸易商，KCB 可决定以执行远程检查来替代现场检查。远程审核的年度认证费用在核算时，需去除差旅费。
